- In addition, pursuant to the State Board of Equalization any vendor wishing to sell taxable merchandise must have a seller's permit. You may acquire a free seller's permit by calling the State Board of Equalization. Please note your seller's permit number at the bottom of this application.

- Absolutely no alcohol will be allowed on the premises other than the alcohol purchased at the event.
- Soft drinks/bottled water are prohibited from being sold at the event.
- All vendors will be responsible for clean-up of their space.
- Vendor fees are non-refundable.

Insurance
