

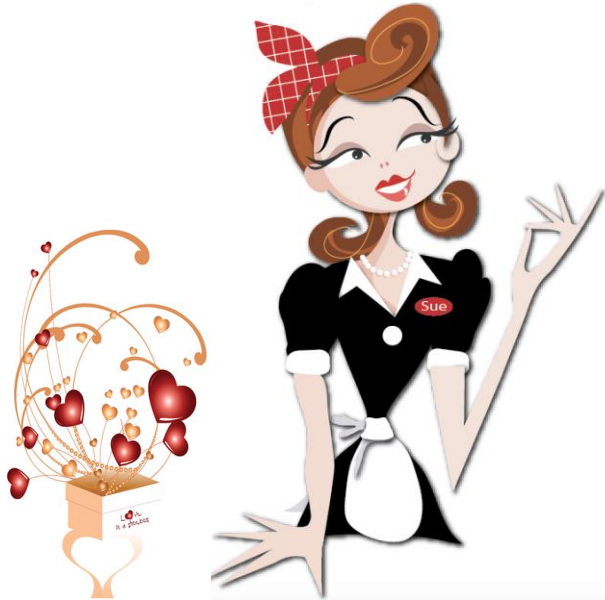

- 1) Aug 26th Show & Shine open to any foreign or American vehicle 1985 or older.
- 2) Only the registered owners of a vehicle may submit an entry. (Proof will be required at check-in).
- 3) Proof of current vehicle insurance (insurance identification card) will be required at check-in.
- 4) If you want to park with another entrant make sure to arrive together at check-in.
- 5) Once your vehicle is parked, it may not be moved until the event is over at 5pm!!
- 6) Entry forms will be processed first-come, first served. (Keep a copy for your records).
- 7) All events are rain or shine.
- 8) Event entry fees are NOT refundable or transferable for ANY reason.
- 9) Each entry form MUST be accompanied with your payment.
