- Sanitation supplies (Bucket, Clorox, wiping towels, food service gloves)
- Table clothes, booth decor

\* Required in accordance to California's Environmental Health Department

## Rules and Regulations

1. Meat must be picked up at specified time and location by event coordinator.
  - a. Contestants must bring a sanitized cooler with ice to pick up their meat
  - b. Contestants must pick up their meat at specified time or forfeit their entry fee
2. Contestants must check in no later than 7am.
3. Contestants must maintain their assigned space in an orderly manner that meets California's Environmental Health Department.

4. All ribs and chicken must be cooked/smoked on site.
5. All meat should be cooked to a safe temperature as recommended by the USDA.
  - a. Potato Salad must be held at a temperature of 40°F or below
  - b. Baked beans must be held at a minimal hot holding temperature of 135°F
6. A maximum of 5 team members allowed per each 10x10 space.
7. All equipment/contestant property must fit within assigned space.
8. Contestants are expected to maintain a professional and friendly demeanor.
9. No alcohol will be allowed on the premises; other than that to BBQ with. All ice chests/contestant space is subject to inspection. A no host bar will be available.
10. Contestants must collect 1 tasting ticket per item sampled. Contestants may not sell additional tastings.
11. Competitors may not sell during the event.

**Cook and/or Team Insurance:** Cook and/or Team acknowledge that the North Bay BBQ Challenge does not maintain insurance covering Cook and/or Team property. If Cook and/or Team desires to insure its goods and/or equipment against theft, damage by fire, accident, or loss of any kind, it shall do so at its own expense.
